Tasmanian Leaders' high-impact Industry, Leadership, Enterprise and Development program (I-LEAD) is for emerging and established leaders in small to medium private sector businesses in Tasmania.

I-LEAD 2020 is designed to increase your leadership capacity against a backdrop of uncertain business conditions. It will be delivered virtually across three months, June-August, with weekly sessions each Friday.

Half-day workshops with industry experts will be delivered across June and August, while July will include connection and peer consulting within smaller groups of I-LEAD participants.

I-LEAD content and process is designed to provide expertise in three key areas:

PERSONAL LEADERSHIP

- Self-awareness to better understand self and others
- Clarity of purpose to ensure passions and values align

STRATEGIC LEADERSHIP

- Personal and business resilience to manage risky environments
- Foresight and strategic thinking to inform better business planning

BUSINESS LEADERSHIP

- Driving efficiency and leading innovation to ensure market relevance
- Developing networks to boundary span and drive industry growth

By the end of the program participants will:

- Better understand themselves as leaders
- Be able to think strategically and long-term to grow their businesses
- Have a wider network and community of business peers
- Be inspired and capable to lead beyond self for the greater good of Tasmania

Program Fees

I-LEAD is a fee-for-service program with entry by application. Some participants self-fund, while others obtain support

To support Tasmanian businesses in this COVID-19 environment, the fee, heavily subsidised by the Tasmanian Government and our industry partners, is reduced to \$195.

Who should apply?

I-LEAD will bring together a group of emerging and established leaders working in small to medium private sector businesses. It will most benefit those with management experience and a strong drive to achieve more for themselves, their organisations and their industry.

Selection Criteria

I-LEAD candidates must demonstrate leadership ability and a commitment to their industry. Applicants will be selected based on the following criteria:

- Employment in a small to medium Tasmanian business, employing less than forty staff, experiencing significant growth or disruption.
- Demonstrated leadership experience and potential, and a goal of increasing leadership capacity.
- Commitment to participate in the program and work with, learn from and share with others.
- Potential to contribute to industry, sector and Tasmania after the program.
